Demonstration against Wallace in Mumbai by MSMRA

Thunderous protest against Wallace management

Wallace remained adamant the matter of settling long pending charter of demand for the sales promotion employees. For the past 6 years the company has been undertaking several unfair labour practices with an objective to harass the field workers and deny their legitimate rights. There has been violations of SPE Act, mental torture of the field workers in the name of sales reviews, Victimisation on sales ground, not convening Grievance Committee Meeting, and tracking, surveillance and intrusion of data privacy. this background, decided, all Sales

working in Wallace irrespective of divisions and designations resorted to a One Day all India Strike on 27th November, 2023. Prior to the strike, several rounds of preparatory meetings at sub units with all Wallace fieldworkers were held which was attended large number of fieldworkers. A letter was sent to the management by the fieldworkers, who are adversely affected by the geo tagged reporting. Fieldworkers aptly sent the protest letter and remained committed even after facing threats and intimidation form the management. Detailed assessments were done by all states regarding participation in the strike.

Subunit level council meetings of Wallace were held and demonstrations organised before Wallace establishments on 27th November, 2023 by all the state units. Štrike Notices were handed over to the Wallace Management during November, 15th-25th 2023 in the field by the council sub- committee and also during the company meetings across the country. On 27th November, 2023, on the day of strike huge number of Wallace fieldworkers assembled in front of Wallace establishments in different states. MSMSRA organized massive protest in front of the head office establishment with Wallace fieldworkers also joining in the protest.

Reception Committee for FMRAI General Council formed



EDITORIAL

FMRAI strike: Carrying forward the rich legacy

of the Industrial revolution of Europe between 1750 and 1850. Indian industries started in mostly Bombay and Calcutta around 1850. The conditions of the workers were deplorable with no working hours, no wage structure, no rules and laws for the workers. Huge numbers of women and children were also employed in these factories. As early as 1877 Indian workers went for strike in the Nagpur Empress Mill, the first workers strike in India. Significant advancement took place with series of strikes all over the country in the last decade of the 1800 demanding fair wage, working time, restricting working for children and women. Strikes by the weavers of Ahmedabad in 1895, in Jute Mills in Calcutta in 1896, by mill workers in Bombay in 1897 and by Press workers in Madras in 1903 wrote histories. By 1900 the workers amalgamated itself with the freedom movement in India. The national leaders took along the workers in industries, realising organized workers would be an asset in freedom movement. The six days' political strike by the workers of Bombay in 1908 against the judgement sentencing Tilak to six years imprisonment, was considered a landmark in our labour movement. After First world war, the consequent economic burden was thrust upon by the industrialists on the workers and as a result series of strikes were organized between 1918 to 1921 across the country. During 1921 alone there were more than 390 strikes involving 6 lakh

In the period of 1918-21 the industrial workers learnt to wage mass struggle over a large area and this led to the formation of a number of good unions. After the second world war there was intense discontent amongst workers and it manifested itself in strikes. While in 1944, the number of disputes was 658, number of workers involved was 5,50,015. The number of stoppages in 1946 and 1947 rose to 1629 and 1811 respectively. The number of workers involved rose to 19,61,948 and 18,40,784.

Today when we have a total anti worker Government and a section of the media and the society continuously trying to paint the striking workers as anti progress, anti growth and anti industry, it is to be remembered that as long as exploitation in economic and working conditions continue, the workers will resort to strikes as a powerful weapon. They are the same class of the valiant workforce that fought for their rights against the British colonial rule.

The first strike by the sales promotion Employees of the country was called by FMRAI in the year 1984. Along with field worker's demands, pro people demands have also been at the forefront of the strike demands. Since then the field workers of the country went for strike twenty four times and a a half day marketing Bandh. There have been one day, two days, three days, five days continuous strike by members of FMRAI. Apart from these there have been month long relay strikes all over the country. Members of FMRAI have also participated in numerous strikes and other agitational programmes of the CITU, NPMO and other fraternal organisations.

Prior to 1984, it was unimaginable that the field workers, scattered over the whole country and working under multiple employers would be able to conduct such apex industrial programme. FMRAI has made that unimaginable thing a reality. In the Diamond Jubilee year of the organization the field workers of the country is geared up for the twenty fifth full day strike in pursuance of their demands and for the interest of the common people of the country. The field workers are the proud inheritors of the striking workers who arose to fight the imperialist forces. Now it is time to strike against the progeny of the employers and pro capitalist, anti India forces that is dividing the nation between haves and have nots and send strong message to them.

Strike preparatory programmes in full swing

The preparatory programmes formulated by FMRAI are being vigorously implemented by the state and sub units across the country. Owing to festive season there was a temporary period during which the implementation of preprogrammes paratory slowed a bit. But with the festivities over, the members are gearing up fast to implement all the preparatory programmes to make the 20th December strike of FMRAI a grand success. Strike notices are submitted to the executives of different companies in the marketplace. GB meetings, conventions are going on across the country to apprise the sales promotion employees about the

demands of the strike. Campaigns are on to the doctors, chemists and other fraternal organisations and all of them are extending their whole hearted support. Already demand memorandums submitted to the Union Labour Minister from all the state units and sub units during 18-25 September, In response to the memorandums submitted, the Union Labour ministry without taking any initiative to resolve the demands, passed the responsibility to state labour departments to look after the labour related demands. It is a clear-cut attempt of the Union Government and Union Labour Ministry to dilute the

demands by sending directives to state labour departments to look after the demands placed by FMRAI. The Sales Promotion **Employees** (Conditions of Services) Act, 1976 is a law framed by the Union Government and it is the Union government only who planned to repeal it. The state governments have no role to address the demand. This deceptive ploy of the anti-worker government must be exposed to all fieldworkers. On 30th November, 2023. strike notice was served to the Prime Minister's Office by the state units and sub units throughout the country. Massive campaign and agitation is in the offing for the Union Government

Waves of strikes among health care professionals across the globe

union members including nurses, nursing assistants, technicians, pharmacists, and other health care workers at Kaiser Permanente (one of the biggest Healthcare provider in US, spreading accross 8 states & Districts with 24000 Doctors, 68000 Nurses, 213000 other staffs including Technicians & front line Workers), went on strike in California in October over a week. It has been hailed as the largest health care strike in recent U.S. history. It is indeed unusual for American medical workers to go on strike. Lives are, after all, in their hands, raising the stakes of any walkout. But health care strikes are more common in other countries, and there is reason to believe Kaiser is on the leading edge of more labor unrest among care providers in this country. Kaiser workers argue that the low pay and benefits, lack of adequate training, and poor working conditions that led them to strike are also putting patients

at risk. Health workers' unions have said that strikes like this can help improve patient care by addressing persistent staffing shortages. They say the better benefits and pay they are arguing for will encourage other workers to fill open positions and stay in their jobs longer. It is nevertheless a relatively new phenomenon for the U.S. medical

their jobs longer. It is nevertheless a relatively new phenomenon for the U.S. medical workforce to demand better working conditions for themselves along with better care for their patients. Kaiser's nurses, techs, and pharmacists are, now, outliers. But they may be showing the way for the people who make up the rest of the vast American health care sector to take a stand for their needs and values. In Becker's Hospital chain, Healthcare Workers are on war path went for Walk off the Jobs, resorted 27 Strikes in 2023 itself, demanding better Patient Care. against Lesser Staffing, improved Working conditions & Employee retention.

In UK very recently in 3rd week of November Consultant Doctors'

union under British Medical Association had undertaken 4 rounds of Industrial Action since June'23 against National Health Services, resorted to 3days Strike in October & achieved their demand of better Wage revision & understaffing causing deteriorated working conditions. Nursing staffs were on agitational path since last year demanding parity with inflammatory market condition for better service conditions in the NHS. In Scotland 40000 Nurses resorted to Strike in 2022 along with other General demands raised by the TUs for revision Service Conditions against high trajectory of inflation. In Germany 25000 Nurses had been to Strikes in 2022.

In France in June 2023 Healthcare Workers resorted to Strike. In Spain at Madrid 20000 Doctors & Nurses participated in Strike in May 2022. In New Zealand 10000 Nurses resorted to Work Slowdowns & Strikes in 2022. In Australia Nurses in New South Wales jumped into Strikes twice demanding better working & service conditions for themselves.

SUN management continues to attack their workers un management illegally stopped salary

un management is trying impose all sorts of unilateral work load on organized field workers. from reporting portal to digital format filling without discussion with Progressive Committee and bypassing written agreement forcing the PSRs to accept the same. With the intention dismantling the union in the company; management is putting enormous pressure on the unionised SPEs. offering Thev are allurement lucrative for leaving union. Some of the betrayers succumbed but a good number of field workers are fighting against the attack. Management squeezed existing rights, issued threat squeezed letters, changed working territory of the PSR including PC members, but all India council issues, took up all and protested against Council strongly opposed new reporting system and unilateral digital activities. The PC pursued the pending COD and rejected the performance-based

increment.

for those who were not complying with their unilateral system, they were not called for company meetings also and denied VDA to these workers from April 23. Every PSR sent protest letter to the management to release all dues and FMRAI took up industrial action against Sun Pharma. Deputation team went to meet management during cycle meetings in three zones, after which management released September salary but October is still pending. FMRAI explored legal corridors for COD and transfer issues and organised demonstrations front of the company establishment. As existing practice, FMRAI is always open negotiation with management, but there will be no compromise rights for workers. FMRAI has further called for more consolidation of all Sun Pharma field workers at subunit level to stop deterioration of working condition and atrocities Company of the management.

Pharma MNCs: Profiteering motives threaten jobs

n continuation of Economic slump all over the World in post covid era big MNC Pharmaceutical houses desperate to maintain their profitability, have started rejigging their organisational structures the downsizing which manpower, they are only taught to sustain their presence World market rather not for better utilisation of manpower sustainable growth. In India we are experiencing a trend of withdrawals of business through marketing direct withdrawals & production units of their products by the MNCs in last one year. The myth of their high Code of Ethics and Corporate Social Responsibilities to serve the mankind has busted. MNCs global strategies have caused such decisions of withdrawal of marketing from lesser profiteering countries like ours, as MNCs in India are facing stiffer competitions from Indian Pharmaceutical houses in marketing

of off-patented drugs. They are not having any exclusive rights product garner which can big profits for them from Indian market. Contimuous movement from FMRAI through vigorous struggle over decades (including Strikes by our members) have put the Union govt of India under duress as FMRAI exposed the impassive attitude Government ofthe rectifying their Price faulty Drug Control mechanism & nexus to loot common people by marketing overpriced Medicines which compelled the Ministry of Fertilizer Petrochemical bring more & more molecules generic into DPCO. This have further declined their astronomical profit which margins led MNCs reluctant continue their operation in our country where people are grappling with unemployment, no money beyond the expenses incurred to sustain livelihoods. The Out-of-Pocket expenses for buying medicines in India, despite being

a poor country, is one of the highest. MNCs motto is simple, more & more unbridled profits with no botheration for the health care benefits of the common people of the country. New technique has been adopted bv Pharmaceutical MNCs now, phasing 011t mainstream marketing & placing the popular Brands in OTC segment so that DPCO doesn't imply on selling products, their for maximisation of their

revenues. Pfizer faces protests against illegal terminations

fizer management called company's annual plan of action meeting (POA) from 29th November to 1st December 2023, at Jaipur for the Sales Promotion Employees working across all division and designation of the company.

Unionised field workers of Pfizer have gone for protest before their management during the Company's Conference at the call of FMRAI, held at Jaipur on issues of illegal terminations of the SPEs' and non implementations of the two interim orders given by the MRTU & PULP Court, Maharashtra in favour of the victimised sales promotion employees

On 29th November 2023 from 9.00 A.M. to 8.00 P.M. retrenched field workers staged dharna in front of Hotel Novotel, the meeting venue. The workers staged demonstrations showing their anger with demand placards and banner while their management entering hotel venue. Inside the meeting, the PSR, those who are in payroll, raised their voice before management and boycotted prize distribution ceremony

and gala dinner offered by the management. Management tried to foil the dharna program instructing hotel management not to allow the program outside the hotel premises. But workers courageously fought and continued with the demonstration. Ultimately, hotel management went back from their agenda, and dharna program continued. At 8.00 P.M. all the unionized field workers met outside the hotel, and a gate meeting was held. Council leaders of Pfizer and FMRAI addressed the members, and all the unionized took dinner together at Jaipur outside

the meeting venue. 30th November 2023, RMSRU members, along with retrenched field workers, staged demonstration before the Pfizer management outside the hotel. Local police did not allow gathering and delegation because of Section 144 imposed due to election proceedings. Local units, along with members, discussed the demands with the police and submitted the memorandum to the administration. The program was continued till 3 PM. Inside the meeting unionized PSR's raised their voice and protested before HR.

demanded resolve the termination issues bilaterally with Welfare Committee. Initially. management adamant about discussing the issue. but due to pressure both from inside and outside, management, announced calling of the grievance committee meeting on 15th December 2023.

Against connivance the police/ bouncers and Pfizer management November, and deliberately trying to suppress our movement, demonstration program was organised on 1st December 2023 before the C & F of the Pfizer as a mark of protest.

Such is the atrocities of the Alkem management. that leading company is having very high attrition rate among the fieldworkers. In recent times the pressure exerted by the management of this company to ensure certain value sales in any headquarters by means whatsoever has a telling impact the fieldworkers. Fieldworkers working this company

getting victimized termination, motivated transfers, harassment in the name of review meeting etc. The all India Council Meeting of Alkem was held in recent past assessed the situation and decided to organize fieldworkers register against all atrocities management Accordingly of programmes designed. November 2023 demonstration organized by KMSRA at Ernakulam which was addressed by KMSRA state leadership. On the next day, i.e. on 29.11.2023 massive demonstration organized WBMSRU in front of Alkem office at Kolkata which was attended by large number of Alkem fieldworkers with huge gathering by WBMSRU members. Protest against Himalaya

he atrocities of the Himalaya Wellness management were aptly protested by the FMRAI members across different states of the country.
